


# **Validating & Accrediting Partners**

EU Business School has partnerships with institutions to offer university degrees to its students. On our Munich campus, our partners are:

UCAM UNIVERSIDAD CATÓLICA DE MURCIA	The <b>Universidad Católica San Antonio de Murcia (UCAM)</b> is an officially recognized university in Spain. It is inscribed in the Registro Universitario de Centros y Títulos (Register of University Centers and Qualifications, RUCT) with the code 066, and is legally authorized to accredit higher education qualifications according to Organic Law 6/2001, 21 <sup>st</sup> December, which pertains to universities. UCAM is accredited by the Agencia Nacional de Evaluación de la Calidad y Acreditación (ANECA). It was awarded a four-star rating overall by QS Stars and was ranked the 34 <sup>th</sup> university in Spain by the Times Higher Education World University Rankings 2023.
DBSS K	<b>Dublin Business School (DBS)</b> is a private higher education institution and Ireland's largest accredited independent provider of higher education. Its programs are accredited by Quality and Qualifications Ireland (QQI), the Irish state body for quality assurance of all education and training services. The institution has 90 awards (including embedded awards) currently validated under QQI. DBS was awarded a four-star rating overall by QS Stars.
UNIVERSITY OF DERBY	The <b>University of Derby (UoD)</b> is public university recognized by the U.K. government's higher education authorities. It is audited by the Quality Assurance Agency (QAA), the official quality assurance body for the Office of Students (OfS), the regulator for higher education in England. UoD was recognized for its world-leading research in the Research Excellence Framework 2021 (REF 2021) and was ranked within the top 50 universities overall in the U.K by the Guardian University Guide 2023.
LONDON METROPOLITAN UNIVERSITY	<b>London Metropolitan University (London Met)</b> has been providing education to individ- uals from all backgrounds since 1848. Its six academic schools teach cutting-edge, relevant courses in arts, sciences, computing, business, law and humanities. Hitachi Capital Invoice Finance named London Met the sixth best university in the U.K. for budding CEOs and Managing Directors, and the 10 <sup>th</sup> best university in the country for entrepreneurs, in large part due to Accelerator, London Met's specialist business incubator.

Degree programs offered on our Munich campus are approved by the Bavarian State Ministry for Science and Art.

# **Professional Accreditations**

EU Business School programs are accredited by the Accreditation Council for Business Schools and Programs (ACBSP) and the International Accreditation Council for Business Education (IACBE). Both of these accrediting bodies are recognized by the Council for Higher Education Accreditation (CHEA), one of the main US higher education agencies. Our institution has also earned the International Quality Accreditation (IQA) from the Central and East European Management Development Association (CEEMAN). Additionally, we have been certified by eduQua in Switzerland.

To ensure that accreditations truly reflect an educational institution's status and academic standards, quality reports must be submitted annually and biennially to these accrediting bodies. # **Bachelor's Degrees**

## Bachelor's Programs (título propio)

EU Business School Munich offers three-year, six-semester bachelor's degrees (*título propio*) (BBA/BA/BS). On successful completion of one of these programs, students earn a university-specific bachelor's degree (*título propio*) awarded by Universidad Católica San Antonio de Murcia (UCAM), Spain, and a Certificate of Specialization in their chosen major from EU Business School Switzerland.

### Bachelor's (título propio) + BA (Hons) in Business Management

On successful completion of one of the three-year, seven-semester bachelor's programs, students earn a universityspecific bachelor's degree (*título propio*) awarded by Universidad Católica San Antonio de Murcia (UCAM), Spain, and a Certificate of Specialization in their chosen major from EU Business School Switzerland. In addition, they earn a state-recognized BA (Hons) in Business Management from University of Derby, U.K. To earn these degree titles, students study in a hybrid learning environment.

### **BA (Hons) Programs**

On successful completion of one of the three-year, six-semester BA (Hons) in Business programs with seven different pathways, students earn a state-recognized Dublin Business School BA (Hons) in Business degree awarded by Quality & Qualifications Ireland (QQI).

## **Master's Degrees**

EU Business School Munich offers one-year, three-term master's programs. On successful completion of one of these programs, students earn a university-specific master's degree (*título propio*) awarded by Universidad Católica San Antonio de Murcia (UCAM), Spain, as well as a Certificate of Advanced Studies from EU Business School Switzerland.

# **MBA Degrees**

### MBA Programs (título propio)

EU Business School Munich offers one-year, three-term MBA programs (*título propio*). On successful completion of these programs, students earn a university-specific MBA degree (*título propio*) awarded by Universidad Católica San Antonio de Murcia (UCAM), Spain, and a Certificate of Advanced Studies from EU Business School Switzerland.

### Additional Qualifications

While completing one of the MBA programs (*titulo propio*), students can also earn a state-recognized **MSc in International Business Management** or a state-recognized **MBA** degree from London Metropolitan University in the U.K.

### **MBA Programs**

EU Business School Munich offers a one-year, three-semester MBA program with four different pathways. On successful completion, students earn a state-recognized Dublin Business School Master of Business Administration (MBA) degree awarded by Quality & Qualifications Ireland (QQI).
